PRESIDENT'S MESSAGE

Labor Cost and Availability Affecting Local Farms

What a busy time of year! I am sure that most of you have been hard at work farming with some of you already past your harvest season. On our farm we have finished Bartlett pear harvest and are partway through the Bosc pear picking. Like many of you, we are having difficulty finding enough laborers to pick our crops.

Unemployment numbers remain really low which is great for the thriving economy, the state, and the whole country; however, people are being pulled away from agriculture to work in other industries (e.g., construction). Labor – both cost and availability – is something my local farm market contacts have all said is having an impact on them. Comprehensive immigration reform with a guest-worker program that is beneficial to both guest workers and employers is needed.

I am honored to represent Oregon on the American Farm Bureau Federation Labor Committee. This has allowed me to see what is happening regarding labor in a more in-depth manner at the national level. There are many legislative concepts and stories that don't make it to the mainstream media. Though it has been enlightening to learn about the political system and the power plays that happen, it has also been very frustrating. In the seven years I have served on the committee, Congress has been unable to pass any immigration legislation. Some of the good folks with whom we share many political beliefs are not with us on the labor issue.

Legislation recently drafted by Congressman Goodlatte (R-Va.) could truly change the situation. The bill, which has not been introduced yet, will overhaul the current H2A guest worker program giving employees more flexibility in who they work for (portability) and diminish some of the expenses that farmers are required to pay – expenses that have made the program too expensive for some small farms to use. This legislation will also help the dairy industry which, by its very nature of needing employees year-round, has not fit well with the current H2A program.

Know that while you are busy working the Farm Bureau Family has your back. Here at Marion County Farm Bureau, your board of directors and very capable staff are watching the issues impacting your farm operation that are controlled by the county government. Oregon Farm Bureau and their team of talented of people are watching for your interests statewide and at the national level preventing the urban legislators from walking all over the rural farm community. The American Farm Bureau Federation is focused on issues at the national level with issues like WOTUS (Waters of the US), The Farm Bill, Labor Reform, The Food Safety & Modernization Act, and so much more.

This winter though, when you have time, we would sure like to see you get involved.

Understanding Water-Use Regulations: Medical and Recreational Marijuana

Marijuana-related water use is subject to the same water-use regulations as any other irrigated crop. Under the Oregon Water Code of 1909, all water belongs to the public. With a few exceptions, cities, irrigators, businesses, and other water users must obtain a water right from the Water Resources Department to use water from any source – whether it is underground, or from lakes or streams. Generally speaking, landowners with water flowing past, through, or under their property do not automatically have the right to use that water without authorization from the Department.

New water permits are not available in many areas of Oregon, so individuals are strongly encouraged to investigate their waterresources options before investing in any project that requires a water supply. Violations of Oregon Water laws can result in civil penalties or prosecution for a class B misdemeanor.

The best way to identify your legal water resources options is to speak with your local watermaster. For more information, you can contact the State of Oregon Water Resources Department at 503-986-0900, or visit its website at <u>www.oregon.gov/owrd</u>.

Like any crop, the growth of marijuana for commercial purposes, whether medical or recreational, is not eligible for groundwater exemptions.

The federal government is responsible for determining whether water from their projects can be used to grow marijuana. Previous statements by the federal government indicate that use of Bureau of Reclamation water for the purpose of growing marijuana is prohibited. Contact the Bureau of Reclamation or your irrigation district for more information.
