SPCC: Spill Prevention, Control, & Countermeasure Plans

SPCC Plan Seminar ~ March 25, 2014

Your facility needs to develop a SPCC Plan if it does any of the following:

- Stores, transfers, uses or consumes oil or oil products above ground in any size tank(s) with a total aggregate volume over 1,320 gallons (containers of less than 55 gallons and/or permanently closed storage containers are exempt from the total); or
- Stores oil under ground in any size tank(s) with a total aggregate volume of 42,000 gallons (except for tanks that are compliant with the state requirement for Underground Storage Tanks); and
- Could reasonably be expected to discharge oil to a “navigable water of the United States” or “adjoining shorelines” considering a worst case possible scenario.

SPCC Plans were required as of May 10, 2013. If you have questions about if your farm requires a SPCC Plan or creating an SPCC Plan please attend one of the complimentary seminars sponsored by Marion County Farm Bureau and Ag Compliance Group.

Fast Fact on Hot Goods

Issue: Two Marion County farms, Pan-American Berry Growers and B&G Ditchen, were forced to collectively pay \$210,000 for alleged minimum wage violations after the U.S. Department of Labor invoked the "hot goods" provision of federal labor law.

Background: In the summer of 2012, USDOL accused the farmers of unfounded labor violations and threatened them with severe hot goods orders. This tactic threatened an embargo on the growers' fresh, perishable blueberries, preventing their customers from receiving the crops, unless large fines were paid and declarations of guilt were signed — even before the alleged labor violations were identified to the farmers and without any due process of law.

On Jan. 15, Federal District Court Judge Thomas Coffin issued a ruling vacating so called consent agreements between USDOL and the two Oregon blueberry farms. Judge Coffin ruled the agreements invalid because USDOL misused its hot goods powers to the point of duress. OFB has engaged on behalf of the growers, B&G Ditchen Farms of Silverton and Pan American Berry Growers of Salem, since Aug. 2, 2012 when the new coercive USDOL tactics first came to light. The two farms employed a legal strategy developed by OFB and were represented by OFB legal counsel Tim Bernasek.

At issue are the two consent agreements signed by the farms after USDOL began calling customers and telling them not to receive berry shipments from the farms because the department was considering using its hot goods powers. The farms had over \$4 million in fresh-market berries in production and could not risk losing the fruit.

Marion County Extension Support Letter

Over the past few years, Marion County Extension budgets have been cut 25 percent because of shrinking federal and state resources. In order to secure a more stable funding system in the future, Marion County will need to ask voters to approve a new tax base just like 21 other counties have done in Oregon. Derek Godwin, Regional Administrator with Oregon State University Extension Services, visited the Marion County Farm Bureau Board of Directors in January 2014 and sought support of a resolution. Below is the letter provided to support this goal.



Citizens of Marion County Extension:

On behalf of the Board of Directors of the Marion County Farm Bureau (MCFB), I am writing to express MCFB's strong support of efforts to establish a Marion County Extension and 4-H Service District. As an organization, our primary goal is to promote educational improvement, economic opportunity, and social advancement for our members and the farming, ranching, and natural resources industry as a whole. We believe that long-term support and sustainability for the OSU Extension Service in Marion County is critical to the vitality, growth, and the economic development of Marion County. Marion County has the highest value of agricultural production of any county in Oregon, with estimated gross sales of \$639 million for all commodities in 2012. Marion County is comprised of approximately 2,700 farms, encompassing 300,000 acres of land or about 40 percent of the County, operated by individuals, families, partnerships and corporations that produce more than 70 different commodities. Agriculture, food processing, the food and beverage industry, and other related industries are important to our county and state's economy with nearly 1 of every 8 jobs in Oregon relying on agriculture. Marion County's economic success is directly tied to the continued success of agriculture production.
