

## **Century Farm & Ranch Program**

The Oregon Century Farm & Century Ranch Program is a statewide recognition program honoring farmers and ranchers who have worked the same land for at least 100 years.

Since the start of the program in 1958, 1,235 farms and ranches across the state have been registered. Oregon has one of the oldest agricultural heritage programs of this type in the entire nation.

There is also a Sesquicentennial Award for farms & ranches that have existed for 150 years or more. Forty-seven (47) farms & ranches have reached the sesquicentennial mark so far.

Successful applicants receive a certificate signed by the Governor. A durable metal road sign to identify their property as having historic Century Farm or Century Ranch status is also available.

Additionally, each family is honored during a special ceremony and reception at the Oregon State Fair.
