HB 3246 - Relating to partition of land zoned for exclusive farm use that contains a dwelling discussed.

Motion: Kathleen Carl moved to direct John Zielinski to report to OFB that board consensus is oppose zone sectioning off for home sites in EFU zoning; Bruce Chapin seconded.

Motion passed with 7 in favor, 1 against, 1 abstain

HB 3296 – Relating to revenues derived from sale of alcoholic beverages; increases privilege taxes imposed upon manufacturer or importing distributor of malt beverages, wine or cider.
