Old Business

OFB Legislative Update – Coming to end of session; few policy bills left, mainly budgets left to vote on. **Intermodal** – No update

Advertising Policy – Board reviewed newsletter ad policy and rate schedule created by Ingalls and Associates.

Motion: Bruce Chapin moves to approve the advertising policy and rates; Dana Estensen seconded.

Motion approved unanimously

Spray Drift – Stuart Olson working with Katie Murray of Oregonians for Food and Shelter to develop protocols to help farmers when spray drift ODA warnings and law suits from neighbors are filed. OFS meeting with an attorney to understand what happens and what farmers should do in hopes of creating publication about spray drift and initial steps for farmers. Short and long term projects in works including: getting information out to farmers; creation of program similar to FEELDS with dedicated educated staff; providing technical assistance and outreach; roundtable meeting with ODA to provide feedback and get immediate responses.
