# Catching Up with the OFB Government Affairs Team

We sat down with members of OFB's Government Affairs Team — Vice President for Government Affairs Mary Anne Cooper and new Director of Government Affairs Lauren Smith — to talk about a couple of the top issues they are working on this fall.

Cooper's issue portfolio includes water, labor, carbon, climate change, pesticides, biotech, agency budgets, agency boards and commissions, food safety, and land use.

Smith focuses on wildlife, wildfire, tax, transportation, energy, and a few land use issues.

OFB is already deep in preparation for the 2022 short legislative session, meeting with lawmakers and looking at which Farm Bureau priorities should be tackled next year.

Ag overtime is definitely going to be a major issue.

"We're encouraging folks to start having conversations with their legislators about what an ag overtime law would mean to them," said Cooper.

#### REDISTRICTING

"OFB has worked on the redistricting issue for over two years," said Cooper.

Last year, OFB led a coalition of organizations, ranging from the League of Women Voters to the Eugene-Springfield NAACP, in an effort to create a ballot measure that would establish an independent redistricting commission.

"So redistricting went to the Legislature in a special session this fall, where we engaged heavily with lawmakers. We had great grassroots engagement from members calling for an independent redistricting process to be adopted. Unfortunately, they did not do that," said Cooper.

#### **DISASTER RELIEF**

There are very few Oregon farmers and ranchers who were not impacted in some way by the unprecedented natural disasters that ravaged the state over the past year.

As Farm Bureau members began applying for federal natural disaster relief programs, service gaps in those programs were identified, and many ag producers either weren't eligible or the coverage they could receive wasn't even worth the effort of the application process.

"We've been advocating with our congressional offices and have had really great support from them in helping get some of the federal gaps resolved and closed," said Cooper. "We've also had good conversations with USDA about implementing flexibility in those programs."

#### **CAP & TRADE**

Farm Bureau members came out in force to help stop the

state's harmful "cap and trade" legislation in 2019 and 2020. However, following Oregon's 2020 short session, Governor Brown issued Executive Order 20-4, which directed the Oregon Dept. of Environmental Quality (DEQ) to promulgate rules to reduce greenhouse gas emissions 80% below 1990 levels by 2050.

"We know this is going to increase costs of gasoline, diesel fuel, propane, and natural gas for producers on a pretty major scale. So, there's a really significant impact for Farm Bureau members," said Cooper.

#### **WILDFIRE**

During the 2021 Oregon Legislative Session, OFB spent hundreds of hours on SB 762, the omnibus wildfire mitigation and suppression bill.

The bill includes the creation of a statewide wildfire risk map, defensible space standards for high and extreme-risk properties, provisions for utility management, and much more.

#### **WILDLIFE**

Smith is also working on two groups organized by the Oregon Dept. of Fish & Wildlife. One group focuses on the management of beavers on federal lands.
