President's Report

Board received letter from Thousand Friends of Oregon about climate friendly communities; letter forwarded to OFB. Reminder about OFB zoom calls at end of month to go over legislative actions. Klamath County reached out for contribution to Wall Street Journal ad but there was not enough notice for Marion County to participate. Discussion of inviting congressional staffers to tour farms during harvest and doing more social media outreach (Instagram?)

New Business

Elections – Staff is ready to send out questionnaire and invitation to candidates immediately after May primaries. Candidates will be invited to June/July meetings.

Hemp – There is county discussion to stop accepting hemp farming applications. MCFB supports all legal ag commodities. There is concern about legal/illegal hemp growing and not enough sheriff resources to police them.

ICE – OFB has updated ICE primer with information about what to do if they come to your farm. Staff will distribute to members through email.

Biosolids – Stuart Olsen presented board information on growing concern about biosolids. Sewer samples being taken to test for antibiotics, drugs, and other toxins. Should have results at May meeting.
