**Spray Drift** – Dana Estensen reported on Feb. 2 meeting with OFS and ODA. Discussion continues and making small steps forward. ODA organizing more formal complaint process and presenting letters on investigation findings.

**Chicken Farms** – Farm in Aurora expanding. Board will continue to follow and watch out for testimony opportunities on SB399 and HB2667

**CPR Classes** – Classes scheduled for March 17, 8-11am, at Oregon Farm Bureau in both English and Spanish **Taxation** – HB2401 presented with mutual agreement to broaden language. Board will continue to follow.

## **MCFB Committee Reports**

Ag Tour Committee – Stuart Olson contacting Detroit Dam and other area stops

Membership Committee – Recently met and brainstorming ideas to engage membership and attract new members. (Signs, stickers, merch, baseball game)

#### AFBF and OFB Advisory Committees – John Zielinski

AFBF Organic and Farm Market committee going to Washington DC this month; legislature not in session but will meet with staffers. No recent OFB committee meetings. John Zielinski introduced reorganized committee structure with Special Committees, Standing Committees, and Organizational Committees (not issue driven). Working on policy language for new structure to present at May Meeting.

#### **OFB District 15 Director's Report** – Bruce Chapin

Board of Directors Meeting held Feb. 7-8. Issues discussed include: idea to convert Bureau of Land Management land from multi-use to single-use for solar farms; sales tax in Tillamook County; and problem with elk herds migrating onto farm land. Also discussed Atlas fertilizer plant moving to Umatilla Military Depot but this very unlikely to happen. 2024 AFBF convention will be in Salt Lake City Jan. 19-24. Discussion of moving OFB annual meeting earlier in the year.

#### YF&R report – Claire Zielinski

Working on upcoming Leadership Conference in Salem and State Meeting in Lincoln City. Plans to hold joint meetings with Clackamas and Washington counties this spring and summer. Ag Tour also being planned for later this year.

#### Women's Advisory Council – Jessie DeJager and Kathleen Carl

Visits to Ronald McDonald houses in Portland, Springfield, and Redmond planned for this spring. WAC will also be participating in Ag Fest and State Fair.
