Summer Ag Institute:

Teaching Teachers About Agriculture

For over thirty years the Summer Ag Institute (SAI) has offered an immersive summer educational program.

Teachers enroll to learn about agriculture and how to enhance their classroom lessons. But the full experience often leaves them with a deeper understanding of the industry and connection to Oregon's producers.

A recent participant had this to say about the program – "it's amazing how they all do their jobs, and how incredible they are to their communities, environment, and employees. Understanding and learning about the demands placed on farmers, and the farming community is so important."

Oregon Farm Bureau members provide tours, cook and serve lunches and even host teachers for a one-night home stay. Additionally, Oregon State



University provides three graduate credits for academic assignments.

Educators from all subjects and grade levels receive valuable lesson materials. Donations help cover the cost of meals, transportation, lodging and OSU tuition. The registration fee is a great value at \$800, as SAI costs more than \$3,000 per participant.

Since its first summer in 1989, SAI

has enrolled more than 1,250 Oregon teachers with the goal of helping promote the importance of agriculture to society.

A Message from the President

It was another cool, wet start to the growing season and bud break in our vineyards was later than usual. But since then, with the warmer weather, we've been accumulating Growing Degree Days at a good clip. That's positive but we also have areas in some blocks that are spotty – the

buds aren't pushing uniformly, and the shoots are either way behind or non-existent. In talking to other growers, field reps/horticulturists, and our extension viticulturist from Oregon State University, the latest theory is it is a carryover from last year's April 15th hard frost. There is nothing we can do at this point, but it is helpful to know the crop yield from those areas will be affected.

The legislative session continues, and we'd like to thank OFB staff and our members who have testified (in person, via zoom, and in writing) for all of your time and effort. It is so important that we stay involved and engaged; it does make a difference. We plan to get a recap of the session at our July Board meeting.

At our board meetings, we usually have a guest speaker in to discuss issues our members are concerned about. In the past few months, we've learned about grants and funding to improve rural broadband internet in Marion County, the Oregon Ag Trust, canola and the specialty seed industry, and biosolids. In March, Eric Lloyd from Oregon Risk Management Services joined our meeting to talk about improving outreach between agriculture and local fire districts and their first responders. He suggested reaching out to our local fire departments, offering to host them for a meeting or training, and helping them understand any hazards that potentially exist at your location. It may help our First Responders, who very often are members of our Ag community.

As a follow-up, our vineyard has been reaching out to our local fire departments to make sure they have the information they need for each of our vineyard locations. Here's the information we have gathered so far.

A pre-fire plan (for example the app Active 911) includes the locations of hazardous materials on site and any other useful information as well as contact numbers. The information is only available to the public with a public record request form. Other fire departments use the same or something similar. Contact your local fire department through their business telephone line.

- Is there an address sign at your field location with numbers big enough to be seen? Fire Departments will often provide one for a small fee.
- Do your employees know the addresses of the locations they are working at? In our case one fire district was able to link the name of one of our vineyards to the street address. We set up a phone "contact" for each vineyard location and shared with our supervisors. Another idea is pocket cards with the information.
- Is there access to the property if it is fenced/gated/locked? Some locks/chains can be cut with bolt cutters (which most emergency responders carry) but in some cases a special fire department lock might be required.
- Who are the contacts for the property? There
 might be someone on site during the day but who
 would they notify after hours.
- We try to minimize the amount of ag chemicals and fertilizers that we keep on hand, and none are extremely flammable or combustible so that didn't seem to be the biggest concern.
- In the vineyards we've gone through so far, gasoline seemed to be the biggest concern. We let them know the maximum amount that we would have on hand and location if they were mapping the location.
- If water is available and appropriate connections are available, that might be helpful if the water source is far enough away from the fire.
- One common hazard is shipping containers that are sealed for use as storage. Make sure the vents are open at all times!
