# **Standing Up for Agriculture** Farm Bureau Members Head to the Capitol

On May 6, Oregon Farm Bureau held one of its most important advocacy events of the year at the Oregon State Capitol -Lobby Day.

It was an opportunity for farmers and ranchers to meet directly with lawmakers to share our stories and experiences in order to influence policies that directly impact Oregon agriculture. It is important that we help the legislators "put a face" on agriculture.

Over 60 OFB members attended the legislative portion of Lobby Day representing 20 of the 32 County Farm Bureaus in Oregon. We were well prepared the visits with our legislators, thanks to a comprehensive legislative issues overview from the OFB Government Affairs Team—Ryan Krabill, Lauren Kuenzi, and Jenny Dresler—and the detailed talking points we received on the key bills of concern.

A panel discussion on water bills, featuring representatives from the Oregon Water Association and the Oregon Water Resources Department, along with a legislative session overview provided by Senator Lieber and Representative Drazan, also helped prepare us for the day ahead.

There were eight different groups visiting the Capital from OFB and our group leaders were tasked with keeping us on point and making sure that we respected everyone's time. In total, OFB members visited 42 of the 90 Representatives and 12 of the 30 Senators. Marion County Farm Bureau members were split into 2 groups and were paired with members

from Clackamas County.

Unfortunately, it was a beautiful day so some members had to farm and couldn't attend but for those who did attend, it was well worth it, and we had some really good discussions.

Group 1 met with Representative Mannix's staff, Senator Thatcher, Representative Diehl, Representative Munoz's staff, and Representative Drazan. Group 2 met with Representative Helm's staff, Representative Hartman, Representative Lewis, Senator Girod, and Representative Wright.

The reception that followed at The Reed in Salem was very well attended and it was a good opportunity to follow up on earlier conversations as well as reach out to more legislators and their staff. It was a very positive experience for all.

Thank you to everyone who attended either the Lobby Day, the reception, or both. We appreciate your time. Marion County Farm Bureau contributed \$500 to sponsor the event and we want to thank Paradis Vineyards, Chapin Orchards and EZ Orchards for donating wine and food to the reception.

Be on the lookout for the next Lobby Day during the long legislative session in 2027.

Lobby Day on May 6 was a great success and we appreciated the great turnout from Marion County. I know a few of you who signed up were unable to attend and assumed that farming had to be done since it was such a beautiful, sunny day.

Next up, the Oregon Agricultural Education Foundation's Farm Dog of the Year event will be held on June 5 at Wooden Shoe Tulip Farm. There is at least one Marion County "Farm Dog" entered and our member Lucas Rue from Victor Point Farms is one of the guest artists for the "Poorly Drawn Pet Portrait Online Auction." Through five intensive sessions held across the state from November through March, participants gain valuable knowledge, build a statewide network, and develop essential leadership skills. The program equips them to strengthen Oregon's natural resource communities and drive meaningful, long-term change across the state.

Marion County Farm Bureau has a \$1,500 scholarship available for a Marion County Farm Bureau member applying to Class 9. The deadline for applications for Class 9 is July 31, 2025, but early submissions are encouraged.
